

# The development of new telecommunication infrastructures in Italy: a public call to boost the speed connection

On January 14, 2022, the Italian Government released a public call to finance investment projects (by way of public grants) for the construction of **new telecommunication infrastructures**, and their relative access points/equipment, capable of providing services with a capacity of 1 Gbit/s in download and 200 Mbit/s in upload. The public call is part of the intervention plan "Italia a 1 Giga" – notified to the European Commission on November 8, 2021 – which aims to fill the gap of ultra-wideband telecommunication and to ensure, by 2026, a speed of connection from fixed networks equal to 1 Gbit/s on the entire Italian territory.

In order to achieve such an ambitious goal, the Italian Government allocated almost 3.8 billion of euros – with grants from the PNNR (Piano Nazionale di Ripresa e Resilienza) – to develop the above-described infrastructures.

The call is entrusted to Infratel Italia – an Italian public company operating in the telecommunications industry for the Ministry of Economic Development – as a general contractor, which is entitled by the Italian Government to grant the financing

# **Application**

Participation to the tender is open to both individual enterprises and groups of enterprises, based in Italy or in any another country of the European Union. If a group of enterprises submits a joint application, such application must identify which of the joint applicants will be responsible for coordinating the project if awarded with the grants. Requirements for participation are outlined in detail in the tender notice. Each applicant must meet all the requirements, both of general order and of professional suitability.



In the public call there are no limits or information related to the control chain of the applicants. Therefore, the public call seems to be open to enterprises and groups controlled or participated by non-UE companies/funds, subject to the applicable regulations in the relevant jurisdiction and a further assessment on the non-participation/conditions for non-EU ultimate control entities, under the EU Recovery Plan related regulations.

The entire tender procedure will be managed by means of an online system, through access to a dedicated portal. The application must be submitted through the dedicated portal, available at: <a href="https://ingate.invitalia.it/">https://ingate.invitalia.it/</a>.

At the time of submitting the application, each applicant must present an **investment project** consisting of:

- I. a **technical part**, concerning the implementation of the infrastructure, and
- II. a **business plan**, concerning the economic development of the project.

The deadline to apply is 16 March 2022 until 13.00 UTC. The deadline to complete the project is 30 June 2026.

## Tender procedure

In order to provide the entire Italian territory with ultrawideband telecommunication, the funding project is divided into batches. Each batch corresponds to a portion of the entire public granting and will be awarded for the implementation of the relevant infrastructures in a specific Italian region. Specifically, the batches are divided as follows:

Each applicant can apply for one or more (even all) batches. However, each applicant can be awarded with a maximum of 8 batches, unless the submitted offers are insufficient to cover all of the remaining batches.

The projects submitted by the applicants will be evaluated by a **technical committee**, appointed by Infratel. The committee will evaluate the projects on the basis of the selection criteria set out in the tender notice.

# Awarding of the grants

At the end of the selection process, for each of the batches awarded the parties (awarded enterprise and Infratel) will sign an agreement, in order to regulate the disbursement of the public grants, which will cover up to a maximum of **70%** of the expenses necessary for the implementation of the Project. The remaining 30% of the expenses will be borne by the awarded enterprise.

Relations between the awarded enterprise and Infratel will be regulated by means of an agreement that will lay down detailed operating procedures regarding the implementation of the infrastructures, technical monitoring, and the procedures for ex-post verification of the profitability of the investment

To guarantee the fulfillment of the obligations undertaken, the awarded company must present a warranty with a duration of six years, starting from the date of stipulation of the agreement itself.

In order to submit a project that is consistent with both the public call notice and the national and European legislation, it is essential for the applicants to be supported by professionals with the necessary skills in the field of public calls, public contracts, etc.
